## Resolution Celebrating President Biden's Historic First Term

**WHEREAS,** President Biden and Vice President Harris got to work on day one of their administration to deliver historic results for the American people; and

WHEREAS, President Biden signed into law the Inflation Reduction Act, which is lowering the cost of prescription drugs, health care, and energy – all while reducing the federal deficit and finally making big corporations pay their fair share; and

WHEREAS, President Biden transformed our economy, growing it from the bottom up and middle out, with one of the strongest job-creation periods in American history, a historic stretch of near record-low unemployment, historically low unemployment for Black and Hispanic Americans, annual inflation falling nearly two-thirds since its peak, real wages being higher now than they were before the pandemic, and record number of Americans having health insurance; and

WHEREAS, President Biden signed into law the Bipartisan Infrastructure Law to make the largest investment in infrastructure improvements in decades, including substantial funding to rebuild roads and bridges, expand high-speed internet access, strengthen supply chains, and

combat the climate crisis – all while creating thousands of good-paying union jobs, and putting America on track to lead the world in the 21st century; and

WHEREAS, President Biden has championed the most ambitious climate agenda in United States history; and

**WHEREAS**, President Biden signed the CHIPS and Science Act into law to lower costs, create American jobs, boost manufacturing, and increase competitiveness with China; and

**WHEREAS,** President Biden signed the PACT Act into law to ensure veterans exposed to toxic burn pits get the health care benefits they've earned; and

**WHEREAS**, President Biden is the first president to bring both parties together to take meaningful action on gun violence in nearly 30 years; and

**WHEREAS,** President Biden signed the Respect for Marriage Act into law to protect the fundamental right to marriage for all Americans; and

**WHEREAS**, President Biden has taken executive action to protect reproductive rights and expand access to high-quality contraception; and

**WHEREAS,** President Biden continues to restore America's standing on the world stage by strengthening our alliances and leading the charge for democracy around the world; and

**WHEREAS**, President Biden has approved more than \$117 billion in student loan debt cancelation for 3.4 million Americans; and

**WHEREAS**, President Biden is taking action to lower the cost of childcare for working families; and

WHEREAS, President Biden has rallied the world in defense of Ukraine in response to Putin's unwarranted aggression; and

**WHEREAS,** President Biden has pardoned all prior federal offenses of simple marijuana possession and has initiated the process to review how marijuana is scheduled under federal law; and

**WHEREAS**, President Biden has delivered criminal justice reforms to improve prison conditions and help people get back on their feet after incarceration, strengthen public safety and public trust, and advance equity and racial justice in policing; and

**WHEREAS**, this White House has also made history by appointing Justice Ketanji Brown Jackson as the first Black woman on the Supreme Court, and has earned confirmation of women and people of color to federal courts at a record pace; and

**WHEREAS**, this historic agenda and record of delivering for the American people led President Biden and Democrats to defy the odds and have one of the best midterms for a sitting president's party in recent history;

**THEREFORE, BE IT RESOLVED,** that in their first term, the Biden-Harris administration has delivered results for American families including historic job growth, historically low unemployment, an American manufacturing boom, and is lowering costs on energy bills, prescription drugs, and more; and

**BE IT FURTHER RESOLVED,** that American people have made clear that they stand with President Biden, Vice President Harris, and Democrats in fighting for economic opportunity, democracy, reproductive justice, environmental justice, and have rejected the extreme MAGA agenda put forth by Republicans; and

## Resolution in Support of President Biden's Ambitious Climate Agenda

WHEREAS, the Biden-Harris administration has done far more to address the climate crisis and environmental injustice than any other administration in our nation's history, including rejoining the Paris Climate Agreement, creating the first-ever National Climate Task Force, establishing the first-ever White House Environmental Justice Advisory Council and White House Office of Environmental Justice, creating a new initiative to deploy and distribute energy resources in disadvantaged communities, advancing clean domestic manufacturing, and rallying more than 100 countries to join the Global Methane Pledge to reduce emissions; and

WHEREAS, President Biden signed the Inflation Reduction Act, the most significant legislative action in United States history to invest in climate solutions, clean energy, and environmental justice, with investments in clean energy and climate creating more than 170,000 new jobs since it was signed into law; and

**WHEREAS,** President Biden signed into law the Bipartisan Infrastructure Law to make the largest investment in infrastructure improvements in decades, including substantial funding to combat the climate crisis – all while creating thousands of good-paying union jobs, and putting America on track to lead the world in the 21st century; and

**WHEREAS**, President Biden and Vice President Harris have earned the first ever joint presidential endorsement of four leading environmental and climate organizations: the League

of Conservation Voters (LCV) Action Fund, NextGen PAC, NRDC Action Fund, and the Sierra Club; and

WHEREAS, President Biden has announced billions in funding to strengthen global food security and understands the effect the deepening climate crisis has on food supply; and

WHEREAS, communities of color bear a disproportionate amount of the social and environmental harm of pollution; and

**WHEREAS**, President Biden believes we must not only act urgently to address the climate crisis, but to also invest in clean energy jobs for a better future; and

WHEREAS, the Biden administration launched the American Climate Corps to mobilize the next generation of clean energy, conservation, and resilience workers – putting them to work conserving and restoring our lands and waters, bolstering community resilience, deploying clean energy technologies, and advancing environmental justice, while creating pathways to good-paying clean energy and climate resilience jobs; and

WHEREAS, the Biden-Harris administration has made historic investments to build community climate resilience including investing in climate resilience and adaptation, enhancing drought resilience across the West, combating the threat of wildfires, protecting communities from extreme heat, reducing flood risks for households and communities, promoting climate-smart buildings and infrastructure, and incorporating climate risk into decision-making; and

**WHEREAS**, Republicans refuse to take action against the climate crisis and threaten to repeal key provisions of President Biden's historic climate agenda; and

**WHEREAS,** Donald Trump called climate change a "hoax," Mike Pence has downplayed its impact, and Ron DeSantis has tried to avoid talking about it entirely as Florida suffers some of the greatest natural disasters; and

**WHEREAS**, none of the MAGA Republicans running for president have offered solutions to combate increasingly common and severe weather events; and

WHEREAS, President Biden continues to deliver on the most ambitious climate agenda in American history which is lowering energy costs for hardworking families, bolstering America's energy security, creating thousands of good-paying union jobs, and strengthening community-driven climate resilience across the country, and more;

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee reaffirms its commitment to protecting our planet, creating good-paying union jobs, making our country more climate resilient, and advancing environmental equity across the United States; and

**BE IT FURTHER RESOLVED,** polluters should be held responsible for meeting strong standards to protect our environment and local government decisions about energy production and environmental protection should not be preempted.

### Resolution in Support of Reproductive Rights

**WHEREAS**, President Biden and Vice President Harris stand with the majority of Americans who believe the right to choose is fundamental; and

**WHEREAS**, since day one, President Biden has made clear that the only way to ensure women in every state have access to abortion is for Congress to pass a law restoring the protections of *Roe v. Wade*; and

WHEREAS, the Biden-Harris administration has taken executive action to safeguard access to reproductive health care services, including abortion and contraception, protect the privacy of patients and their access to accurate information, promote the safety and security of patients, providers, and clinics, and coordinate the implementation of federal efforts to protect reproductive rights and access to health care; and

WHEREAS, President Biden and Vice President Harris believe contraception is an essential component of reproductive care and have also taken action to strengthen access to affordable, high-quality contraception; and

**WHEREAS**, Vice President Harris has been leading the administration's response and fight to protect reproductive rights, meeting with advocates, doctors, and women across over 20 states and close to 50 meetings; and

WHEREAS, while every 2024 Republican presidential candidate is running on an extreme anti-choice record, President Biden is continuing to fight for reproductive justice and has promised to veto any national abortion bans passed by Congress; and

**WHEREAS**, President Biden and Vice President Harris have earned the presidential endorsement of four leading reproductive justice and women's organizations: Planned Parenthood Action Fund, NARAL Pro-Choice America, EMILY's List, and the National Organization for Women PAC;

**THEREFORE, BE IT RESOLVED THAT,** that the Democratic National Committee reaffirms its commitment to fighting for reproductive justice and protecting the hard-won freedoms of women; and

**BE IT FURTHER RESOLVED THAT,** that the Democratic National Committee remains resolute in its support for passing legislation that codifies the protections of *Roe v. Wade* into law; and

**BE IT FURTHER RESOLVED THAT,** we commend the Biden-Harris administration for their commitment to fighting to protect a women's right to choose and expanding access to reproductive health care, including high-quality contraception for women living across the country.

## Resolution in Support of Gun Violence Prevention

**WHEREAS**, there have been hundreds of deadly mass shootings since the beginning of the year; and

WHEREAS, we join families across this country in grieving the deeply painful loss of loved ones due to gun violence; and

**WHEREAS**, we believe that people should not be afraid to go to work, attend schools or places of worship, the movie theaters, or simply walking down the street; and

**WHEREAS**, Democrats believe now is the time for action and we must put an end to this senseless gun violence; and

**WHEREAS**, Congress can take action on reasonable gun safety laws, while also respecting the Second Amendment of our Constitution; and

WHEREAS, President Biden has made historic progress to reduce gun violence with more executive action than any other president at this point in their administration; and

**WHEREAS**, thanks to relentless gun violence survivor advocates, Congress passed and President Biden signed the Bipartisan Safer Communities Act - the first significant federal gun safety legislation in nearly 30 years; and

WHEREAS, President Biden prioritized our children and our safety over the gun lobby and signed an executive order to increase the number of background checks conducted before firearm purchases, increase appropriate use of red flag orders and safe storage of firearms, address the loss or theft of firearms during shipping, hold the gun industry accountable; and

WHEREAS, the MAGA Republicans running for president continue to prioritize the gun lobby over protecting our children and keeping our communities safe; and

**WHEREAS**, last year House Democrats passed a bill to ban assault-style weapons, as well as legislation raising the age to purchase semi-automatic weapons to 21 — both of which were filibustered by the gun lobby in the Senate — and similar legislation has been reintroduced by Democrats in both houses this year; and

WHEREAS, after Republicans let the 1994 Assault Weapons Ban, which the original passage was led by then-Senator Biden, expire, mass shootings tripled;

**THEREFORE, BE IT RESOLVED THAT,** Democrats mourn the loss of Americans from recent mass shootings and join President Biden in calling for Congress to take further action, including by banning assault weapons to ensure all Americans can live freely without the fear of senseless gun violence.

### Resolution in Support of Protecting Our Right to Vote

**WHEREAS,** President Biden and Democrats recognize that the right to vote, and to have one's vote counted, are bedrock principles of our democracy; and

**WHEREAS**, since their first days in office, President Biden and Vice President Harris have prioritized strengthening our democracy and protecting the sacred right to vote in free, fair, and secure elections; and

WHEREAS, President Biden and Vice President Harris have mobilized the entire federal government to strengthen our democracy and protect voters from suppression and subversion; and

WHEREAS, Republican-controlled state legislatures across the country have passed laws making unprecedented attacks that make it harder to vote, and conservative majority Supreme Court rulings have rolled back protections for voting; and

**WHEREAS**, Republicans have made concerted efforts to make it more difficult for voters, particularly in communities of color, to have their voices heard; and

Resolution on Reporting of Cruel and Inhumane Tactics Being Used by State Officers at the Texas Border

**WHEREAS**, Greg Abbott reached a new level of depravity earlier this summer with Texas' floating border barriers, intended to deter asylum-seeking migrants with the threat of drowning rather than legal repercussions; and

**WHEREAS**, we wholeheartedly support urgent, holistic reforms to our immigration system to give much-needed relief to our border communities — but violence against migrants is not the answer; and

**WHEREAS**, we desperately need Republicans in Congress to finally put partisan politics aside and work with us in good faith to fix our country's broken immigration system. Operation Lone Star is barbaric, puts National Guardsmen and law enforcement in dangerous situations, and border communities should not be used as collateral damage;

## Resolution Regarding Deadnaming of Transgender and Nonbinary Persons

WHEREAS, deadnaming is the intentional or accidental use of a name no longer used by transgender or nonbinary persons; and

WHEREAS, deadnaming is being codified by state governments, local governments, and school boards as a means to not only discriminate against transgender and gender nonconforming persons, but to deny them the right to exist and the life, liberty, and pursuit of happiness guaranteed others; and

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee (DNC) affirms its commitment to support the rights and legal recognition of transgender and nonbinary persons in taking an unequivocal stand against deadnaming within and without the Democratic Party writ whole; and

#### Resolution to Eliminate Child Marriage

WHEREAS, Child, early, and forced marriage carries a long history of abuse and coercion, and it contributes to the human trafficking challenge, the Democratic National Committee joins with the United Nations 1 in:

WHEREAS, Marriage before the age of 18 years, especially when forced, is a violation of children's human rights, there is not a single good reason why any (state or federal) government should continue to expose minors to these great harms and abuse; and

WHEREAS, "Although advocates have succeeded in getting seven states to ban child marriage with no exceptions, forty-three states still allow marriage under the age of eighteen, and seven

states have no minimum age requirement for marriage so long as there is a parental or judicial waiver";

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee calls upon Congress and all states to pass legislation to eliminate early and forced marriage.

#### Resolution Honoring the Life and Career of Bill Bradbury

WHEREAS, the Honorable Bill Bradbury was born on May 29, 1949, in Chicago, Illinois; and

**WHEREAS,** Bradbury graduated from the University of Chicago Laboratory High School in 1967; and

WHEREAS, Bill attended Antioch College in Yellow Springs, Ohio, where he studied communications before moving to Oregon in 1969 where he worked as a news reporter, director, and producer in Bandon, Eugene, and Portland; and

WHEREAS, representing coastal communities of Coos and Curry counties, Bill Bradbury was elected to the Oregon House of Representatives in 1980. In 1981 Bradbury was diagnosed with multiple sclerosis; and

WHEREAS, Oregon voters elected Bill Bradbury to serve in the Oregon State Senate in 1984; and

**WHEREAS**, Bradbury was elected by his colleagues to serve as state Senate majority leader in 1986, and state Senate president in 1993; and

WHEREAS, Bradbury championed vital environmental protection bills in the Oregon Legislature. Bill developed Oregon's Salmon and Trout Enhancement Program (STEP), crafted a relief plan to assist displaced timber workers, and prevented offshore oil drilling off the Oregon Coast; and

**WHEREAS**, Bradbury passed key economic development legislation to establish Small Business Development Centers (SBDCs) at Oregon's community colleges; and

**WHEREAS**, when Bradbury left the Oregon Legislature in 1995, he founded For the Sake of the Salmon, a regional nonprofit aimed at restoring salmon stocks and critically important watershed restoration projects; and

WHEREAS, Governor John Kitzhaber appointed Bradbury to be Oregon's 23rd secretary of state in November 1999; and

WHEREAS, Secretary Bradbury was elected to the office in 2000 and reelected in 2004; and

**WHEREAS**, Secretary Bradbury oversaw the implementation of Oregon's vote by mail program; and

WHEREAS, Secretary Bradbury instituted ORESTAR, an online tracking system of transparently reporting political contributions and financial transactions in the state of Oregon; and

WHEREAS, Bradbury served as an automatic unpledged delegate for Barack Obama (2008); and

WHEREAS, Bill Bradbury – the longest serving and highest ranking official in the U.S. with MS – ran for the Democratic nomination for governor of Oregon in 2010. While Bill lost the primary election to former Governor John Kitzhaber, he earned the endorsements of Vice President Al Gore, Governors Howard Dean and Barbara Roberts; and labor unions such as Oregon Education Association (OEA), the American Federation of Teachers (AFT-Oregon), and the Oregon School Employees Association (OSEA); and

**WHEREAS**, Bill continued to inspire and educate following his service in elected office as he presented more than 200 Al Gore-trained, climate-change themed slideshow presentations warning about the existential threat facing our planet; and

**WHEREAS**, Bill was happily married to Katy Eymann, lawyer and daughter of Dick Eymann, former speaker of Oregon's House of Representatives; and

WHEREAS, Bill is survived by his wife Katy and his two daughters, Abby and Zoë; and

WHEREAS, Bill Bradbury's unbridled enthusiasm for electing progressive Democrats, protecting our environment, and advancing forward-thinking ideals was inspiring and contagious; and

WHEREAS, Bill Bradbury personifies a positive attitude, collaboration, and progressivism; and

**WHEREAS,** Bill Bradbury passed away on April 14, 2023, doing what he loved: cruising around the world with his beloved wife Katy;

#### Resolution Honoring the Life and Career of Ada Deer

WHEREAS, Ada Elizabeth Deer was born on August 7, 1935, in Keshena, a town on the Menominee Reservation in northern Wisconsin; and

**WHEREAS,** Ms. Deer graduated from the University of Wisconsin with a bachelor's degree in social work in 1957 and received her master's degree in the same subject from Columbia University in 1961; and

**WHEREAS**, she came to prominence in the early 1970s, when she moved to Washington, D.C., to help steer the effort to overturn the federal government's policy of "termination" — a series of laws that since the late 1940s had restricted and in some cases eliminated tribal sovereignty in favor of integration within the rest of American society; and

**WHEREAS**, she spent years meeting with representatives and senators, writing briefs and organizing protests. In 1973, President Richard M. Nixon signed the Menominee Restoration Act, and in 1975, the tribe regained its sovereignty. Ms. Deer became its first chairwoman; and

WHEREAS, Ms. Deer ran for office several times, though never successfully. She ran twice for Wisconsin secretary of state and once for Congress, in 1992, losing a high-profile race against a Republican incumbent, Scott Klug, that nevertheless brought her yet another distinction: as the first Native American woman to win a Democratic primary for federal office; and

WHEREAS, her campaign got her the attention of the incoming Clinton administration, which, despite her outspoken criticism of Washington, named her assistant secretary of the interior for Indian affairs in 1993, putting her in charge of the Bureau of Indian Affairs; and

**WHEREAS**, she served as chairwoman of the Menominee tribe until 1976, after which she became a lecturer in American Indian studies at the University of Wisconsin. She ran the program from 2000 until her retirement in 2007; and

**WHEREAS**, Ada Deer, a member of the Menominee tribe in Wisconsin who was a leading figure in the movement for greater Native American sovereignty since the 1960s, a role she played both as a critic of the federal government and as a top official within it, died on August 15, 2023, in Fitchburg, Wisconsin;

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee honors Ada Deer for her contributions to our country and the Democratic Party and offers its condolences to her family and friends.

**WHEREAS**, he joined the national office of the Building Service Employees International Union in Washington in 1960 and in 1995 stepped in as president of the AFL-CIO; and

**WHEREAS,** Mr. Donahue was a fierce labor organizer and distinguished himself as a theorist on the future of U.S. organized labor and global competition; and

WHEREAS, Mr. Donahue passed on February 18, 2023;

John Tanner announced his retirement, after more than 20 years in the seat. Herron ultimately lost the general election to Republican Stephen Fincher; and

After performing initially under a different name, the group was rebranded in Belle's honor — campanas is Spanish for bells — at the suggestion of the late José "Pepe" Martinez Sr., a leader of the famed Mariachi Vargas de Tecalitlán; and

**WHEREAS**, Belle was active in many community organizations and served on numerous boards, including the Mexican American Unity Council, the Texas Diabetes Institute, the Ford Foundation, the Vikki Carr Scholarship Foundation, and the San Antonio Area Retired Teachers Association; and

WHEREAS, Belle was inducted into the San Antonio Women's Hall of Fame and received the Lifetime Achievement Award from the Main Plaza Conservancy, the 2018 Inspire Award of SAISD Foundation, the Distinguished Service Award from SAISD, the Lifetime Achievement Award from the San Antonio Hispanic Chamber, the Our Empowering Women of San Antonio award, and the LULAC National Education Award; and

WHEREAS, following Army service, Robinson earned a bachelor's degree in sociology from Virginia Union University, a historically Black institution, in 1967, and graduated from Harvard Law School in 1970; and

**WHEREAS**, Robinson practiced civil rights law in Boston, won a Ford Foundation fellowship to work in Tanzania, then worked for two members of Congress – Rep. William L. Clay Sr. of Missouri and Rep. Charles C. Diggs Jr. of Michigan, both founding members of the Congressional Black Caucus; and

WHEREAS, in the late 1970s he chaired a working group which led to the creation of TransAfrica, which focused on influencing U.S. foreign policy concerning African and Caribbean countries; and

**WHEREAS**, Robinson led TransAfrica from its incorporation in 1977 until he stepped down as executive director in 2001; and

**WHEREAS**, under Robinson's leadership, TransAfrica became Black America's premier foreign-policy think tank, earning the backing of Black celebrities including Harry Belafonte, Arthur Ashe, Ruby Dee, Ossie Davis, Dick Gregory, and Muhammad Ali; and

WHEREAS, Robinson led daily demonstrations in protest of apartheid outside of the South African embassy that led to thousands of arrests, including Arthur Ashe, Stevie Wonder, Delegate Walter Fauntroy, Gloria Steinem, and numerous members of Congress; and

WHEREAS, TransAfrica, and Mr. Robinson in particular, was credited with forcing the United States to confront the apartheid regime in South Africa and push for the release of South African activists, including Nelson Mandela; and

**WHEREAS**, Robinson taught at the Dickinson School of Law at Pennsylvania State University, and wrote several books, including "Defending the Spirit: A Black Life in America," "The Debt: What America Owes to Blacks," and "The Reckoning: What Blacks Owe to Each Other"; and

WHEREAS, Randall Robinson died on March 24, 2023, in St. Kitts;

WHEREAS, after returning to Texas in 2018, Stenholm was a popular public speaker and became an adjunct professor at Tarleton State University in Stephenville, Texas, teaching agricultural policy; and

WHEREAS, Sandra served in different capacities at the state government level, having worked for the Department of Agriculture under Jim Hightower, Governor Ann Richards and the Comptroller's office under John Sharp; and

He served as president of the Northeast Austin Democrats from 1978 to 1980, Democratic precinct chairman for Travis County from 1981 to 1988, county Democratic chairman for Travis County from 1996 to 1998, chairman for the North East Bexar County Democrats from 2000 to 2003, a NAACP member and legal panelist, member of the American Civil Liberties Union, and member of the Labor Council for Latin American Advancement; and

WHEREAS, David Van Os was a labor attorney; and

WHEREAS, he served as general counsel for the Texas AFL-CIO from 1983 to 1989 and was named Civil Libertarian of the Year for the Central Texas ACLU in 1990 and was the in-house district counsel for the Communications Workers of America (CWA) in Austin from 1981 through 1984; he continued serving as district counsel for CWA after co-founding a private law firm in 1984, and remained CWA's district counsel for its five-state District 6; and

WHEREAS, David served on the board of directors and as assistant treasurer for the Texas Equal Access to Justice Foundation, by appointment of the Texas Supreme Court from 1985 to 1995. In 1990 he was honored with the President's Citation for Achievement in Civil Rights by the NAACP. The Texas Women's Political Caucus named him "GOOD GUY OF THE YEAR" in 2002; and

WHEREAS, David Van Os's clients have included steelworkers (USW), carpenters (UBC), electrical workers (IBEW), sheet metal workers, firefighters, musicians (AFM), Deputy Sheriffs of Bexar County, the Texas AFL-CIO, and others; and

WHEREAS, Van Os and his wife, Rachel, met on a CWA picket line in 1993. In the 1980s and early 1990s he also represented the NAACP and LULAC in a series of controversial voting rights lawsuits and desegregation suits involving the City of Austin and the Austin Independent School Board; and

WHEREAS, he spent the first 23 years of his legal career in Austin before he and Rachel moved their growing family to San Antonio in 1999; and

**WHEREAS**, after moving to San Antonio he continued to be involved in high-profile issues such as obtaining a temporary restraining order on behalf of the American Federation of Government Employees (AFGE) that temporarily halted the unpopular closing of Kelly Air Force Base; and

**WHEREAS**, as the Democratic candidate for attorney general, Van Os took his campaign directly to the people. He pledged to visit all 254 counties in Texas during the 2006 election cycle and ran for statewide office to serve fellow Texans; and

WHEREAS, he was a loving husband and father; and

WHEREAS, David Van Os passed away on January 3, 2023; and

**WHEREAS,** David was truly a great American, labor attorney, Longhorn, public servant, and family man;

# Resolution Honoring the Life and Career of Dick Clark

WHEREAS, Richard Clarence "Dick" Clark was born in the unincorporated community of Paris, Iowa, in Linn County, on September 14, 1928, and graduated from Lamont High School in 1947; and

**WHEREAS**, following service in the U.S. Army, Clark graduated from Upper Iowa University in 1953, and earned a master's degree and a Ph.D. from the University of Iowa in 1959; and

**WHEREAS,** Clark taught history and political science at Upper Iowa University before working as an aide to U.S. Rep. John Culver; and

WHEREAS, in a year when Republicans Richard Nixon and Robert Ray won Iowa's votes for the presidency and for governor, Clark defeated two-term Republican incumbent Sen. Jack Miller in a 1972 campaign where he walked across Iowa on foot, greeting Iowans one on one, winning with 55.1% of the vote; and

WHEREAS, Clark served on the Agriculture, Public Works and Foreign Relations committees during his time in the Senate, and helped create the Commodity Futures Trading Commission; and

WHEREAS, Clark was best known for chairing the Foreign Relations subcommittee on African affairs, a role that gave him a platform to speak out on African policy issues, and especially his support for Black liberation movements; and

WHEREAS, Clark advocated for the end of apartheid in South Africa and traveled across sub-Saharan Africa, educating himself on policy issues, and met with activists including Steve Biko, a leader of South Africa's anti-apartheid movement; and

WHEREAS, in addition to his advocacy for the end of apartheid in South Africa, Clark sponsored a measure banning American aid to rebels in Angola, where paramilitary groups

were fighting the country's leftist government with support from South Africa and the CIA, and later championed a 1977 bill that restored an embargo on Rhodesian chrome, as part of an effort to promote a transition toward Black-majority rule in the country; and

WHEREAS, following his Senate term, President Jimmy Carter appointed Clark as an ambassador at large, serving as the administration's coordinator for refugee affairs in 1979, where he worked to provide aid and housing for tens of thousands of people fleeing wars and famine in Southeast Asia; and

**WHEREAS,** in 1980, Clark worked for U.S. Sen. Edward Kennedy's unsuccessful campaign for the Democratic presidential nomination; and

WHEREAS, Clark then became a senior fellow and director of the congressional program at the Aspen Institute, where he spent the next three decades combining his interests in teaching and politics, and launched a program to educate members of Congress on foreign policy issues, organizing dozens of bipartisan conferences and retreats, including sessions on the politics and history of the Soviet Union, Vietnam and South Africa; and

WHEREAS, Dick Clark died on September 20, 2023, at his home in Washington;

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee honors Dick Clark for his contributions to our country and the Democratic Party and offers its condolences to his family and friends.

## Resolution Honoring the Life and Career of Thomas Michael Conway

WHEREAS, Thomas Michael Conway was born in Newark, New Jersey on February 14, 1953; and

**WHEREAS,** Tom served four years in the United States Air Force as an aircraft mechanic until 1974; and

WHEREAS, Tom was recruited by Bethlehem Steel to work as a millwright in the company's Burns Harbor coke plant in northwest Indiana, where he soon became involved in the steelworkers union, joining Local 6787; and

WHEREAS, Tom began work as a union leader almost immediately. When Bethlehem Steel tried to lay off workers during the economic downturn of the late 1970s, he helped his local push back, persuading the company to first cut nonunion contractors. In the end, no union members lost their jobs; and

WHEREAS, he moved from the local to the union's international staff in 1987, and in 2005 he became its vice president for administration. He also served as the secretary of the union's Basic Steel Industry Conference, which designed negotiating strategies and set policy agendas for local and state lobbying efforts; and

WHEREAS, along with serving as a union leader, Tom helped negotiate a series of corporate loans and consolidations during the late 1990s in the middle of the Asian economic downturn. Millions of tons of cheap steel flooded into the United States, and Tom's aid helped stabilize the industry and ensure its growth; and

**WHEREAS**, Tom was named president of the United Steelworkers Union in 2019, and he played a crucial role in creating a steel industry that is stable and profitable, which has 850,000 union members — a situation attributable in no small part to Mr. Conway's leadership. In addition to being the acting president, he was a founding board member of the BlueGreen Alliance, a coalition of labor groups and environmental organizations, and a strong advocate for the transition away from fossil fuels; and

WHEREAS, Tom was an unofficial advisor and friend to President Joe Biden; and

WHEREAS, Thomas Michael Conway passed away on September 25, 2023;

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee honors Thomas Michael Conway for his contributions to our country and the Democratic Party and offers its condolences to his family and friends.

### Resolution Honoring the Life and Career of Dianne Feinstein

WHEREAS, Dianne Emiel Goldman was born in San Francisco on June 22, 1933; and

WHEREAS, she attended Stanford University, where she was student body vice president and received a bachelor's degree in history in 1955; and

WHEREAS, while at Stanford, she established the university's first chapter of Young Democrats and was elected student body vice president, the highest office a woman could hold at that time; and

**WHEREAS,** in 1960, California Gov. Pat Brown named her to the California Women's Board of Terms and Parole, her first job in public service; and

**WHEREAS**, beginning in 1969, Feinstein served for nine years as a San Francisco County supervisor, eventually serving as the first woman president of the San Francisco Board of Supervisors; and

WHEREAS, she became the first woman mayor of San Francisco in 1978 following the assassination of Mayor George Moscone and Supervisor Harvey Milk; and

WHEREAS, Feinstein won the mayor's office in her own right in 1979 and, after surviving a recall, was reelected in 1983; she was named the nation's "Most Effective Mayor" by City and State Magazine in 1987; and

WHEREAS, Dianne Feinstein led the city through the AIDS crisis, helped create thousands of jobs, and saved the famed cable cars and secured funding to rebuild the system in time for the 1984 Democratic National Convention held in San Francisco; and

WHEREAS, in 1992, she and Barbara Boxer won their Senate seats to become the first women elected as U.S. senators from California in what became known as the Year of the Woman – an election that sent 24 new women to the House of Representatives and brought the total number of female senators to six; and

WHEREAS, Senator Feinstein was one of the first women members of the Senate Judiciary Committee, becoming the first woman ranking member of the committee in 2017, where she helped shape policy on criminal law, national security, immigration, civil rights and the courts and confirm hundreds of federal judges, including 143 jurists nominated by President Biden; and

WHEREAS, she was the first woman to chair the Senate Rules and Administration Committee in 2007; and

WHEREAS, Senator Feinstein was the first woman to chair the Senate Select Committee on Intelligence, a position she held for six years beginning in 2009, where she oversaw the passage of six intelligence authorization bills; and

WHEREAS, Senator Feinstein counted among her most notable achievements in the Senate the enactment of the federal Assault Weapons Ban in 1994, a law that prohibited the sale, manufacture and import of military-style assault weapons, and a review of the CIA's detention and interrogation program that culminated in the 2014 release of the report's executive summary and passage of legislation ensuring that certain post-9/11 interrogation methods are never used again; and

WHEREAS, she was the driving force in enacting legislation to preserve millions of acres of land in the State of California, from the redwoods of Headwaters Forest to San Francisco Bay and Lake Tahoe, and devoted particular attention to protecting the California desert through the establishment of Death Valley National Park, Joshua Tree National Park, the Mojave National Preserve, the Santa Rosa and San Jacinto Mountains National Monument, the Mojave Trails National Monument, the Sand to Snow National Monument, and the Castle Mountains National Monument; and

WHEREAS, Senator Feinstein led Senate efforts to secure marriage equality, combat LGBTQ discrimination, defend reproductive rights, combat violence against women, protect victims of trafficking, reform our health care system, provide immigration benefits for agricultural workers, increase fuel economy standards, improve the safety of personal care products, address nuclear waste storage, fund breast cancer research, counter illicit narcotics, enhance cybersecurity information sharing, increase resources to fight wildfires, and manage the water supply system of the State of California; and

WHEREAS, Senator Feinstein was reelected to the Senate five times; including in 2012 when she received the most popular votes for any Senate candidate in the history of the United States, she was one of the first two female Jewish senators, the longest-serving senator from California, and the longest-serving female senator in U.S. history; and

WHEREAS, President Joe Biden said upon her passing: "Often the only woman in the room, Dianne was a role model for so many Americans – a job she took seriously by mentoring countless public servants, many of whom now serve in my Administration. She had an immense impact on younger female leaders for whom she generously opened doors. Dianne was tough, sharp, always prepared, and never pulled a punch, but she was also a kind and loyal friend, and that's what Jill and I will miss the most;" and

WHEREAS, as House Speaker Emerita Nancy Pelosi recalled, Dianne savored being a mentor and was always willing to learn. In 2017, she wrote a law to protect millions of young women athletes, who shared with her the horrors of sexual abuse in amateur sports. She then gave us all a Master Class on the subject, demonstrating how women's personal safety, freedom to pursue careers free of harassment or assault, and the right to choose are firmly connected. Dianne recognized the impact laws have on people's lives and the statement laws make about our national values. And it is fitting that she cast her final Senate vote to advance legislation to keep the government open for the people; and

WHEREAS, Senator Feinstein inspired generations of women to break barriers and seek positions of leadership, to find common ground in order to get things done for the people they represent, and to serve with grace, strength, and integrity; and

WHEREAS, she was a beloved sister, wife, mother, and grandmother; and

WHEREAS, the State of California and the United States lost a trailblazing lawmaker and dedicated public servant when Senator Feinstein died on September 28, 2023, at her home in Washington;

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee honors Senator Dianne Feinstein for her contributions to our country and the Democratic Party and offers its condolences to her family and friends.

**WHEREAS**, the 1975 graduate of South Carolina State University had become a fixture on HBCU campuses as he sought to make them centers of excellence for a particular specialty; and

**WHEREAS**, the initiative, which he dubbed SC HBCU Institutes of Innovation and Information, has received \$1.4 million through the state budget over the last two years; and

WHEREAS, in 2018, Scott was picked by Democratic gubernatorial candidate Marguerite Willis as her running mate for what would be an unsuccessful run for the party nomination, but she touted the pick as a historic opportunity to pair a woman and an African American on the ticket for South Carolina's top two posts; and

WHEREAS, Scott was a former clerk and deacon of his church, New Ebenezer Baptist; and

**WHEREAS**, South Carolina state Sen. John Scott, a Democratic legislator for 33 years, died Aug. 13 at the Medical University of South Carolina, at age 69;

**THEREFORE, BE IT RESOLVED**, that the Democratic National Committee honors John Scott for his contributions to our country and the Democratic Party and offers its condolences to his family and friends.

Resolution Honoring the Life and Career of Bill Spriggs

**WHEREAS**, William E. Spriggs was born on April 8, 1955, in Washington, D.C., to Thurman and Julienne (Henderson) Spriggs; and

**WHEREAS**, he graduated from Williams College in Massachusetts in 1977 with a bachelor's degree in economics and political science; and

**WHEREAS,** Spriggs received a doctorate in economics from the University of Wisconsin-Madison in 1984; and

WHEREAS, he taught economics at North Carolina Agricultural and Technical State University in Greensboro and Norfolk State University in Virginia, and after taking a series of jobs in government and think tanks, Spriggs returned to academia in 2005 as a professor of economics at Howard University where he also served as the chair of the economics department; and

**WHEREAS**, in 2009, President Barack Obama appointed Spriggs as assistant secretary for the Office of Policy at the United States Department of Labor, where he served until 2012; and

WHEREAS, Spriggs served as the chief economist of the AFL-CIO from 2012 to 2023, where he was an important and critical voice on the economic policies that exacerbate racial disparities in economic outcomes, particularly for Black workers, and was an incisive critic of the field of economics approach on race; and

**WHEREAS**, in his role with the AFL-CIO, he chaired the Economic Policy Working Group for the Trade Union Advisory Committee to the Organization for Economic Cooperation and Development, and served on the board of the National Bureau of Economic Research; and

WHEREAS, his previous work experience included roles leading economic policy development and research at the Economic Policy Institute, the National Urban League; the U.S. Small Business Administration, and the U.S. Department of Commerce; as an economist for the

Democratic staff of the Joint Economic Committee of Congress; and, as staff director for the National Commission for Employment Policy; and

**WHEREAS,** Spriggs served on the boards of the National Employment Law Project, and the Eastern Economic Association; and

WHEREAS, he was a former president of the National Economic Association, the organization of America's professional Black economists, and president-elect of the Labor and Employment Relations Association; and

WHEREAS, Spriggs was one of the most prominent and internationally recognized economists of his generation, deeply committed to racial and social justice; and

**WHEREAS**, his many honors included the National Academy of Social Insurance Robert M. Ball Award for Outstanding Achievement and the NAACP Benjamin L. Hooks Keeper of the Flame Award; and

**WHEREAS,** President Joe Biden said Spriggs "was a towering figure in his field, a trailblazer who challenged the field's basic assumptions about racial discrimination in labor markets, pay equity, and worker empowerment"; and

WHEREAS, on June 6, 2023, Bill Spriggs passed away in Reston, Virginia, at the age of 68;

**THEREFORE, BE IT RESOLVED,** that the Democratic National Committee honors Bill Spriggs for his contributions to our country, the field of economics, the labor movement and the Democratic Party, and offers its condolences to his family.
